Manuscript submission guidelines

The journal publishes original papers and sources in the fields of art history, musicology, and theatre studies. The submitted manuscript should not have been previously published or considered for publication in any form. Reviews and abstracts of scholarly publications, conferences, and exhibitions are also accepted. The languages of the journal are Lithuanian and English.

The journal uses double-blind review process. The manuscripts submitted shall be reviewed by at least two independent reviewers holding a PhD degree in the respective field. This journal provides an immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge.

Formatting requirements. The manuscript (including notes, bibliography, and appendices) should not exceed 40,000 characters, including spaces, and should be submitted as a WORD document. The illustrations should be scanned in *.jpg, *.tif formats and have a minimum resolution of 300 dpi. The entire manuscript should be 1.5-spaced, in Times New Roman 12 pt font. The e-mail address and phone number of the author should be given.

Structure of the article. The manuscript should be arranged in the following order: the title, first name(s) and surname(s) of the author(s), title(s) and address(es) of the affiliation(s), an abstract, keywords, the main text of the article with conclusions, an alphabetical list of bibliographical references and sources, a summary (up to 1500 characters, including 5–8 keywords), a list of illustrations. Notes should be given as footnotes. The date of submission of the article should be given at the bottom.

Requirements for the text. The names of scholars quoted should be given in full at the first mention; in subsequent references, the initial(s) is not required unless there are two or more identical names, in which case the initial(s) should precede the surname. Names of the authors of sources and publications in Cyrillic alphabet should be transliterated (Romanised). Old personal names can be presented in modern orthography with their original form given in the list of references and sources.

Quotations in other languages may be given either in the original language in the text or as a translation, in which case the original quotation should be given in a footnote.

Quoted publications should be presented in footnotes in a shortened form: the author's name, the year of publication, the number(s) of the relevant page(s). Full information about a publication should be given in the list of bibliographical references and sources.

The quoted works and sources should be given in alphabetical order by the last name of the first author of the work or the first word of the title. An entry in the reference section should include, **for books**:

The surname(s) and initials of the author(s). *The title of the publication*. Place of publication: the publisher, year of publication, the number of pages.

For archival sources: Date. Type of the document. *The full title or the abbreviation of the archive*. Collection, inventory, file, page/leaf number.

Ethics of the journal. The journal adheres to the Code of Conduct and Best Practice Guidelines for Journal Authors (2011) and the Code of Conduct for Journal Publishers (2011) released by the Committee on Publication Ethics (COPE).

Ethics of authors. Authors shall guarantee that:

- The article is their original work, which does not violate intellectual property and other human rights;
- The article is void of plagiarism or self-plagiarism; the reference section is not dominated by personal articles
- The article has not been submitted to other publications at the same time;
- Citations are appropriately used; other authors' works and conclusions on the issue in question are mentioned; the sources not mentioned in the text are not included; self-citation is avoided;
- All sources of funding and support are openly declared.

Ethics of reviewers. Reviewers shall ensure that:

- The review is professional, objective, meets the standards of correctness, and is written within the time limit intended for it;
- Confidentiality is ensured;
- Any current or potential conflicts of interest are declared;
- Editors will be informed in case the author(s) of the article is(are) suspected of the breach of ethics.

Ethics of editors. The editors of the journal shall ensure that

- Decisions are taken objectively, impartially, fairly, and are based on the value of the article being submitted and its suitability for its publication in the journal.
- Peer-reviewing and the identity of the reviewers are confidential;
- The rules and requirements binding to the members of the editorial board, authors, and reviewers of articles are complied with;
- Each volume is published in time and in line with the established periodicity of the journal.

Copyright. Copyright is defined in the Law on Copyright and Related Rights of the Republic of Lithuania.

Protection of personal information. Personal and contact details submitted to the journal shall be used exclusively for their intended purpose, that is, journal publishing. They shall not be made public or communicated to the third parties (unless it is required by law).

Journal fees. There are no journal fees.
